Terms & Conditions :

For In-service Doctors

- The engagement of such Associate Professor, for fulfilling the NMC requirement and for teaching purposes, shall not be treated as promotion. The pay of such Associate Professor on deputation shall be regulated as per the terms and conditions under deputation to Foreign Service. They shall only be allowed the corresponding of the academic pay matrix for MCTs as per the scale of pay of Associate Professor prescribed under ORSP(MCT) Rules,2019 vide Govt. Letter No: 9684/H Dt 02.05.2022
- The engagement shall be purely temporary and on year to year tenure basis, subject to satisfactory performance or till appointment of Doctors as Associate Professor on regular basis through DPC or attaining the age of 70 years, whichever is earlier.
- Other terms and conditions will be guided as per Govt in H & FW Letter No 9684/H dt. 02.05.2022 & clause-9 of Health & F.W Department Resolution No.8967/H dt.25.04.2022.

Contractual Doctors:

- Contractual Associate Professor is entitled for remuneration of Rs. 2,00,000/- per month. In addition to the above, any incentive as notified by Govt. shall be allowed.
- The engagement shall be purely temporary and on year to year tenure basis, subject to satisfactory performance or till appointment of Doctors as Associate Professor on regular basis through DPC or attaining the age of 70 years, whichever is earlier.
- Other terms and conditions will be guided as per Govt in H & FW Letter No 9684/H dt. 02.05.2022 & clause-9 of Health & F.W Department Resolution No.8967/H dt.25.04.2022.

The selected candidates are to sign an agreement to the above effect. The Direct Candidates shall join within 7 (Seven) days, before the Dean & Principal of concerned institution and

the Inservice Candidates shall join immediately before the Dean & Principal of concerned institution after being relieved from their present place of posting.


The selected candidates cannot participate in monthly recruitment of other GMCHs of the state for a period of 1 year.




